

Lluís Feliu (ed.), *Studies in Sumerian Civilization. Selected writings of Miguel Civil* (Barcino Monographica Orientalia 17; Barcelona 2017. ISBN 978-84-475-4188-1. pp. xiii + 715. Price €45.00.

Over the course of his long and eminent career, Miguel Civil has produced a wealth of articles on Sumerian and related topics, that are scattered in various publications (journals, collective works, Festschriften etc.). Over fifty of these have now been collected in one volume and are therefore more accessible to interested readers – of which undoubtedly there will be many. After the preface and an appreciation of the author (by G. del Olmo Lete) the papers are reprinted in three sections, as follows.

In spite of the age of some of the articles, this work is a mine of information, not only on what for most readers is an esoteric language (i.e. Sumerian) but also on the civilizations of ancient Mesopotamia and beyond.
